It is notified for the information of valued members of the Multan Chamber of Commerce & Industry, Multan that according to the rules of Trade Organizations Ordinance-2007 your next Annual Subscription of the Multan Chamber of Commerce & Industry, Multan for the year 2009-2010 shall become due for payment on 1st March, 2009.

As per rules of Trade Organizations Ordinance-2007 there are two following classes of membership in the Multan Chamber :-

1. **Corporate Class:**

A member of a trade organization which is either a body corporate or a multinational corporation with its head office or branch office in Pakistan or a sales-tax-registered manufacturing concern or a sales-tax-registered business concern having annual turn-over of Rs.50 million or above shall be called " Corporate member ".

2. **Associate Class:**

A member of a trade organization which is **not** a body corporate or a multinational or not a sales-tax-registered manufacturing concern or a sales-tax-registered business concern not having annual turn-over of Rs.50 million or above shall be called " Associate Member ".


